

PRIVACY POLICY

Kofo Owolabi, c.o.b. KOAR Travel (hereinafter KOAR Travel/us/we/our), understands and respects the importance of your privacy and is committed to safeguarding your personal information. In providing services to you, personal information must be collected from you and this policy outlines how we treat your personal information after it has been collected.

KOAR Travel reserves the right to change, modify, alter or otherwise update this Privacy Policy at any time. Any and all changes to our Privacy Policy will be reflected in the information listed on this page and are effective when they are posted.

Information Collection, Retention, and Use

KOAR Travel may collect information relating to you and your usage of our Website. Some of the information we collect may be considered personal information. The personal information we may collect includes your name, email address, phone number, address, and website usage data.

We use your personal data to provide and maintain our services, manage your account with us, assist in performing any contract entered into with us, to contact you, to manage and respond to your requests and enquiries, and to provide you with news, information and offers that we offer that may be of interest to you, unless you have opted not to receive such information. We may also use your information for purposes related to business restructuring and/or business transfers, data analysis, and identifying usage trends.

We will retain personal information only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use personal information to the extent necessary to comply with our legal obligations.

Usage Data is data which is automatically collected related to your use of our Website, which may include your device’s IP address, device ID, browser type and/or version, unique device identifiers, the webpages visited, time, date and duration of webpage visits, and diagnostic data.

We will retain Usage Data for internal analysis purposes. It is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of the Website or we are legally obligated to retain this data.

Disclosure of Information

We may share your information in the following situations.

- With service providers who process data on behalf of KOAR Travel in order to provide, facilitate, monitor and analyze the service and Website use and contact you.

- With our affiliated companies and agents with common control or joint venture partners, who will be bound by the same privacy policy herein.
- With business partners so that you may receive products, services or promotions.
- With other users when you interact in public or interactive areas with other users. If you use a Third-Party Social Media Service to register and/or interact on the Website, other users and/or social media contacts may be able to view your activity, communicate with you, and view your profile, which may include your name and/or photos.
- If KOAR Travel is involved with a business transfer, restructuring, merger or sale, your data may be disclosed. We will provide notice before any transfer of data to a new entity and your data becoming subject to a different Privacy Policy.

Cookies and Tracking Technology
